## 1 INTRODUCTION

- 1.1 This Terms and Conditions apply to the conduct of EG&H Integrated Concepts LTD PLENTYMILLIONS™ National Lottery Game as licensed pursuant to the National Lottery Act of 2005
- 1.2 The Terms and Conditions in force at the time of purchase of PLENTYMILLIONS™ National Lottery ticket(s) are contractually binding on EG&H Integrated Concepts LTD and the Player
- 1.3 These Terms and Conditions are in force for the Company national lottery Game draws conducted on or after March 01, 2014 until subsequent amendments are made by EG&H Integrated Concepts LTD
- 1.4 By successfully undertaking Full Registration and accepting the Terms and Conditions, a Player can access and play the Company's National Lottery Games via the web site, agent locations and mobile applications
- 1.5 These Terms and Conditions shall be available at the places of business of EG&H Integrated Concepts LTD and the company web sites including <https://www.plentymillions.com>

## 2 DEFINITIONS

- 2.1 Unless otherwise specified in a schedule, the following definitions apply:

Account	means a Player' s or Prospective Player's or Agent's account maintained on the Central Computer System
Act(s)	means the National Lottery Act of 2005 as amended from time;
Agent	means a person or company authorized by EG&H Integrated Concepts LTD to sell PLENTYMILLIONS™ National Lottery game(s)

Central Computer Systems	means the computer systems operated by, or on behalf of, the Company from time to time which, facilitate the playing of, and contain a record of all selections made in relation to PLENTYMILLIONS™ National Lottery game(s)
Claimant	means a Player who submits a claim for a prize payment within the applicable claim period
Claim Period	means the period ending 180 days after a Draw Date in which a Prize is claimed
Commission	means the National Lottery Regulatory Commission, being the body established to regulate the National Lottery or such other body as may carry out such functions from time to time.
Company	means EG&H Integrated Concepts LTD, a company registered in Nigeria, whose registered office is at Plot 575b Muhammadu Sanusi III, Gwarimpa, Abuja. FCT.
Close of Acceptance of Lottery	means the day and time of day determined by EG&H Integrated Concepts LTD after which Entries into a Draw of Plentymillions Lottery game(s) will not be accepted;
Debit Card	means making payment for PLENTYMILLIONS™ lottery game with debit card
Dormant Account	means an Account which a Player or a Prospective Player has not logged into or otherwise accessed or used for a continuous period of one

	hundred and eighty (180) days and which does not have an active balance associated with it
Draw	means the drawing or determination of the Winning Numbers in PLENTYMILLIONS™ Lottery game(s) using a Drawing Device or otherwise in the manner described in these Rules;
Draw-Based Game	means a National Lottery game which can be played by Players via the Company web site or USSD channel or POS device, the result of such game being determined by a draw and in which a Selection is recorded on the Company's Central Computer System subject to these Terms and Conditions.
Drawing Devices	means equipment used to conduct Draws of PLENTYMILLIONS™ Lottery Games(s)
Entry	means the numbers in PLENTYMILLIONS™ Lottery which have been selected by a method as directed by EG&H Integrated Concepts LTD via the Web Site, mobile application, POS Terminal, SMS or USSD application which have been recorded in EG&H Integrated Concepts LTD Computer lottery system
Full Registration	means the process of successfully registering as a Player by opening an Account and providing all required information in order to be able to play the Company National

	Lottery games;
Game(s)	means a Draw-Based or Instant National Lottery Game(s) Played via the Company web site, POS terminals and mobile applications
Game History	means the information held by the Company relating to the Games played by a Player, including the outcome of each Play.
Game Procedure	means any procedures or conditions (including, without limit, the relevant name for a Game, how a prize is won, Prize Structure and Play Style) issued by the Company in addition to these Terms and Conditions which apply only to a particular Draw-Based Game which are identified by the Company as Game Procedures.
Games-Related Information	means a Player's Transaction History, Game History and any information the Company requires a Player or Prospective Player to submit to it before providing that Player or Prospective Player with access to the Games which may include, without limitation, the Player's or Prospective Player's name, user name, Password, telephone (including mobile phone) number, credit card details, debit card details, Mobile Money details, Security Information, address details, Identification Information, email address, date of birth and gender.

Identification Information	means information used to establish the identity of a Player or Prospective Player, including information required by the Company to verify the authenticity of that information. Such information could include any element of the Games-Related Information and, in the case of a Claimant, that Players passport, driver's license, National Identity Card, Voter's Car or Government Issued Employment Card
Internet	means the world wide connection of computer networks providing for the transmittal of electronic mail, on-line information, information retrieval and file transfer protocol
License	means the National Lottery license held by the Company
Malfunction	means a failure of a Drawing Device or any part of it (or any occurrence which causes a failure of the Drawing Device or any part of it) to operate in the manner in which it is designed to operate
Minor	means a person who has not reached the age of 18 years and not eligible to play the National Lottery games
Mobile	means a mobile phone that is capable of running mobile applications and exchanging data either through mobile phone network or wireless network connectivity, which has been

	registered to play PLENTYMILLIONS™ lottery games via the Company web site or mobile application.
National Lottery	has the meaning set out in the Act
National Lottery Trust Fund	has the meaning set out in the Act
Password	means the alpha-numeric identifier used by a Player or Prospective Player to identify himself when accessing the Company National Lottery game(s) through the Company web site or mobile application
Play	means an entry into PLENTYMILLIONS™ National Lottery game (other than a Try Game) in accordance with the Play Style.
Player	means a person who has successfully completed Full Registration and who is eligible to purchase Plays via his Account and whose Account has not been terminated, cancelled, suspended or closed
Privacy Policy	means the policy established by the Company in respect of the use and storage of a Player's or Prospective Player's personal information (including, but not limited to, Games-Related Information), as such policy may be amended from time to time.
Prize	means any prize determined in accordance with these Rules;
Prize Fund	for each PLENTYMILLIONS™ lottery means an amount of not less than

	the percentage of all Subscriptions received in respect of a particular Draw of PLENTYMILLIONS™ lottery Game
Prize Pool	is an amount equivalent to 50% of all Subscriptions received in PLENTYMILLIONS™ lottery Game which is the amount to be returned to players being the sum of all Prizes payable from the Prize Fund;
Prize Structure	means the value and odds of winning Prizes for an individual Game and the prize tiers within a Game and the chances of winning a Prize in each tier in an individual Game as determined by the Company and as specified in the relevant Game Procedures
Security Information	means the information (for example, mother's maiden name and place of birth) which Players are required to provide to the Company for security purposes as part of registration.
Selection	means the set of numbers chosen by a Player (whether chosen himself or by luck pick) for the purpose of a Play or Plays
Text Message Confirmation	means a Text Message sent to a Player by the Company confirming that Player's entry into the relevant Draw-Based Game(s).
Transaction History	means the financial information relating to a Player's use of his Account.
Unutilized Funds	means any funds credited to a

	Player's Account (including Prizes) that are not used by the relevant Player.
Web Site	means the Internet site located at <a href="https://www.plentymillions.com">https://www.plentymillions.com</a> or where a player may purchase entries

- 2.2 Reference to one's gender includes all other genders
- 2.3 Reference to the singular shall include the plural and vice versa
- 2.4 Reference to a person shall include all natural persons and corporation persons, context permitting

### 3 EFFECT OF THESE TERMS AND CONDITIONS

- 3.1 Entry into the Company national lottery Games is open only to persons 18 years and over resident within the jurisdiction of the Federal Republic of Nigeria.
- 3.2 By purchasing a lottery ticket, from the Company, all players agree to be bound by these rules. All players shall accept as final, decisions made by the Company pursuant to these rules and decisions made by the Company as to meaning and effect of these rules.
- 3.3 The Company may at any time amend these Rules in accordance with the License or Acts. If such amendment results in the invalidity of any Lottery Ticket already issued, the holder of such Lottery Ticket or may apply for a refund of amount paid for that Lottery Ticket but the Company shall not be liable for any other loss or damage suffered by the player.
- 3.4 If there is an inconsistency between the instructions on the Company Website, mobile application, Lottery Ticket or promotional and point of sale materials and these Rules, these Rules prevail to the extent of the inconsistency.
- 3.5 If it is held by a court of competent jurisdiction that: ! any part of the Rules are void or illegal or unenforceable; or ! the Rules would be void, voidable illegal or unenforceable in whole or part unless a part were

severed from these Rules Then that part shall be severable from and shall not effect the continued operation of the remainder of the Rules.

## 4 OBJECTIVE

4.1 The objective of the Company PLENTYMILLIONS™ national lottery Game(s) is for a Player to correctly select all Draw Winning Numbers, in an Entry Panel, for any given PLENTYMILLIONS™ Game & Draw.

## 5 PLAYERS REGISTRATION AND ACCOUNT OPERATION

### 5.1 Criteria

5.1.1 A person intending to open an account may not do so unless the following criteria are satisfied:

5.1.1.1 The intending player is not a minor

5.1.1.2 The intending player does not already have an account

5.1.1.3 Where a Debit card will be supplied for payments, the said card has not been reported lost or stolen or used in another account.

5.1.1.4 Where required, the intending player will be required to verify the authenticity of the information supplied during player registration to the Company by a method determined at the sole discretion of the Company

5.1.2 The Company reserves the right to deny the intending player Full Registration for any reason in its absolute discretion

5.1.3 The Company reserves the right to carry checks or request information from a Player from time to time before and or after registration to check that the Player meets the criteria set forth in clause 3

5.1.4 An intending Player will be required to supply certain information to the Company during registration process which will enable the

Company determine the intending Player's eligibility as set forth in clause 3. This information may include but not limited to:

- Last Name
- First Name
- Middle Name
- Date of birth
- Mobile Phone Number
- Email address
- Home Address
- State of residence
- Country
- Government issued identification

5.1.5 Once an intending Player completes Full Registration, he will become a Player and be able to purchase plays

5.1.6 The Company reserves the right to request further information from a Player to verify the authenticity of the Player's age or identity

5.1.7 A registered Player may begin to play lottery Game(s) as soon as their accounts have been opened. If the Company subsequently discovers that a Player is not or no longer eligible to open an Account, the Company reserves the right to take all appropriate steps in relation to that Player and his Account, including, without limitation, suspending or terminating that account and investigating security breaches.

## 5.2 Password Security

5.2.1 It is a Player's responsibility to keep their passwords secure and secret at all times and take steps to prevent the unauthorized use of their passwords to access the Company websites and mobile applications

## 5.3 Crediting Funds

5.3.1 Once a Player has completed Full Registration, he will be able to credit funds to his virtual wallet or account using his Debit card, mCash, mobile moneyor by direct bank deposit.

- 5.3.2 A Player can use the Deposit feature on the Company's Website or mobile applications to add funds to his account.
- 5.3.3 The minimum amount that can be credited to a Player's virtual wallet or account using a Debit card or from mobile money is ₦500 (five hundred Naira)
- 5.3.4 The maximum amount that can be credited to a Player's virtual wallet using a debit card or mobile money is ₦100,000.00 (one hundred thousand Naira).
- 5.3.5 A Player may not receive nor is entitled to any interest for unutilized funds (including lottery winnings) deposited in his virtual wallet or account.
- 5.3.6 The Company may, at its discretion, impose limits on the number of times a Player may make a Play or the amount of money a Player may spend over a defined period or both. Limits imposed under clause 5.3.5 shall be notified to the affected Player as determined by the Company
- 5.4 Funds Withdrawal
  - 5.4.1 A player may withdraw or transfer winnings from his virtual wallet to his bank account domiciled in Nigeria, using the Withdraw Funds feature in the Company Website and mobile application
  - 5.4.2 Funds deposited to a Player's account using either a Debit card, direct bank deposit, PLENTYMILLIONS™ voucher or partner mobile money cannot be refunded to Player and must be used up in Playing PLENTYMILLIONS™.
- 5.5 Chargebacks
  - 5.5.1 If a Player notifies his bank, Debit card or mobile money provider that unauthorized use of his Debit card or mobile money account undertaken in relation to his account or virtual wallet and the bank, Debit card, debit or mobile money provider requests the relevant sums be returned by the Company to the Player's Debit card or mobile money account ("Chargeback"), the Company will suspend the Player's account and ask the Player to contact the Company customer support.

The Company reserves the right to debit the Player's Account with the amount of the Chargeback together with any funds that the Player has used to purchase Plays and which are subject to that Chargeback. If that debit results in a negative balance in the relevant Player's Account, the Company reserves the right to recover that balance from the Player and the Player will not be able to make any further Plays unless and until the balance has been so recovered.

## 5.6 Termination/Suspension of Account

5.6.1 If any information provided by a Player is provided fraudulently, or is inaccurate, or incomplete, the Company has the right to terminate or suspend the Player's account and refuse any and all current or future playing of PLENTYMILLIONS™ national lottery Game

5.6.2 The Company may terminate or suspend the provision of PLENTYMILLIONS™ national lottery Game(s) and access to a Player's Account immediately and without prior notice on :-

- a) on breach of these terms and conditions
- b) on breach of PLENTYMILLIONS™ game Rules
- c) for repair or maintenance work to repair or upgrade the Central Computer System
- d) for any other reason at the sole discretion of the Company

## 5.7 Warranties and Indemnities

5.7.1 Each Player warrants that they will only use their online account, the Web Site, the mobile applications in accordance with these Rules and Regulations and in an appropriate and lawful manner. Each Player shall not authorize or permit any other person to:-

- a) receive, access or transmit any content that is obscene, offensive, threatening, defamatory, in breach of confidence, in breach of any Intellectual Property right (including without limit, Copyright) or otherwise objectionable or unlawful: or
- b) knowingly or recklessly transmit any content (including, without limit, viruses) through the Web Site of mobile applications which shall cause

or be likely to cause, detriment or harm, to any degree, the Central Computer Systems owned by the Company or others; or

- c) hack into or make excessive traffic demands or cause any impairment of the functions of the Central Computer Systems, deliver or forward chain letters, "junk mail" of any kind, or otherwise engage in any behavior intended to inhibit others from playing PLENTYMILLIONS™ national lottery game or any other website, or which is otherwise likely to damage the reputation or business of the Company or of any third party

5.7.2 Each Player, agrees to indemnify the Company against any costs, losses, damages and expenses which the Company may suffer or incur arising out of or in relation to any claim, legal proceeding or demand made by any third party due to or arising out of that Player's wrongful or negligent use of his Account, playing of PLENTYMILLIONS™ national lottery Games, access to the Site and/or the Central Computer System, or breach by that Player of these Rules and Regulations.

## 6 Liability

- 6.1 Players acknowledge and agree that in accepting these Terms and Conditions they do not rely on, and shall have no remedy in respect of, any statement, representation, warranty or understanding (whether negligently or innocently made) of any person (whether or not such person is a party to these Terms and Conditions)
- 6.2 In the event of a failure or malfunction of the Central Computer System, which impacts upon the Player limits detailed in Clause 5.3.3 and 5.3.4 above and which has a material adverse effect on any Player, the Company shall either:

- a) refund to the affected Player the sums paid by that Player in purchasing Plays above that Player's limit and recover any Prizes paid into that Player's Account in respect of those Plays; or
  - b) refund to the affected Player the sums paid by that Player in purchasing Plays above that Player's limit, net of any Prizes paid into that Player's Account in respect of those Plays
- 6.3 Without prejudice to Clause 5.8.1 above or any other Clauses, the Company shall not in any circumstances be liable for any loss of whatever nature, including, without limitation, loss of profits, indirect, special or consequential loss, suffered or incurred by any Player, any holder or owner of a Play, any Claimant or any other person arising from the withdrawal of any Game or from the participation or nonparticipation of any person in any Game, including the loss, for whatever reason, of the chance to participate in PLENTYMILLIONS™ national lottery Game. In particular, but without prejudice to the generality of the foregoing, the Company shall not be liable to any person:
- a) for any event beyond the Company's reasonable control including, but without limitation, any act of God, war, strike, lockout, industrial action, fire, flood, drought, tempest, power cut and/or failure or obstruction of any network, broadcasting or telecommunications service;
  - b) for the failure of, or damage or destruction to, or any errors caused by the computer systems or records of the Company or any third party (including, without limitation, the Site, and/or the Central Computer System), or any part of any of the foregoing;
  - c) for delays, losses, errors or omissions in or made by the bank system or mobile money provider;
  - d) for any other action or event which prevents or hinders the issue of a valid Play (including without limitation the failure of the Web Site to display correctly on any device used to view the Site):

- e) for the refusal to sell a Play to any person or to allow any person to play a Game;
- f) for any losses caused by Players including misuse or unauthorised use of Passwords or Mobiles, money lost by playing the Games and failure or malfunction of the equipment or technology of the Player or his internet service provider, or mobile phone network operator

## 7 General

- 7.1 Any person who purchases a Play or submits a Play for validation or who claims a Prize in whatever capacity agrees to be bound by the provisions of any applicable legislation, the provisions of these Terms and Conditions, the Game Rules, the Game Procedures and any Game Specific Rules (all of which may be amended from time to time) and any other statements or explanations issued from time to time by the Company in respect of the relevant Game.
- 7.2 Each Prize winner is deemed to acknowledge that, if and to the extent that the Company is legally obliged to provide a third party with details of any Prize claimed by or on behalf of, or paid to the Prize winner, the Company shall be entitled to do so.

## 8 Law

- 8.1 These Terms and Conditions and the rights and obligations of the Company and Players set out herein shall be governed by and construed in all respects in accordance with the laws of the Federal Republic of Nigeria and the parties hereby submit to the exclusive jurisdiction of Nigerian courts.
